The #1 most frequently cited deficiency on annual surveys in Massachusetts is F880 Infection Control with 43.8% of nursing facilities cited in 2024. This “Back to Basics: Infection Control 101” workshop series will provide an overview of essential infection control practices, including hand hygiene, appropriate PPE use, isolation precautions, and environmental cleaning.
